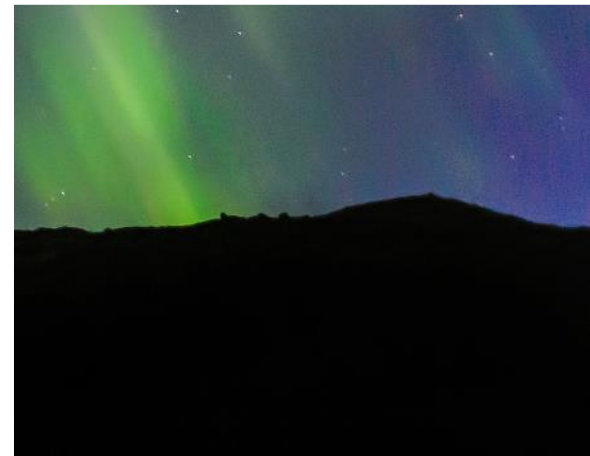

Cluster vs. ecosystem



Cluster

A cluster is a **geographic concentration** of interconnected companies, suppliers, service providers, and supporting organisations in a particular field.



Ecosystem

An ecosystem is an **environment** of people, resources, processes and technology of (cluster) companies, suppliers, service providers, and supporting organisations, **interacting as a system.**

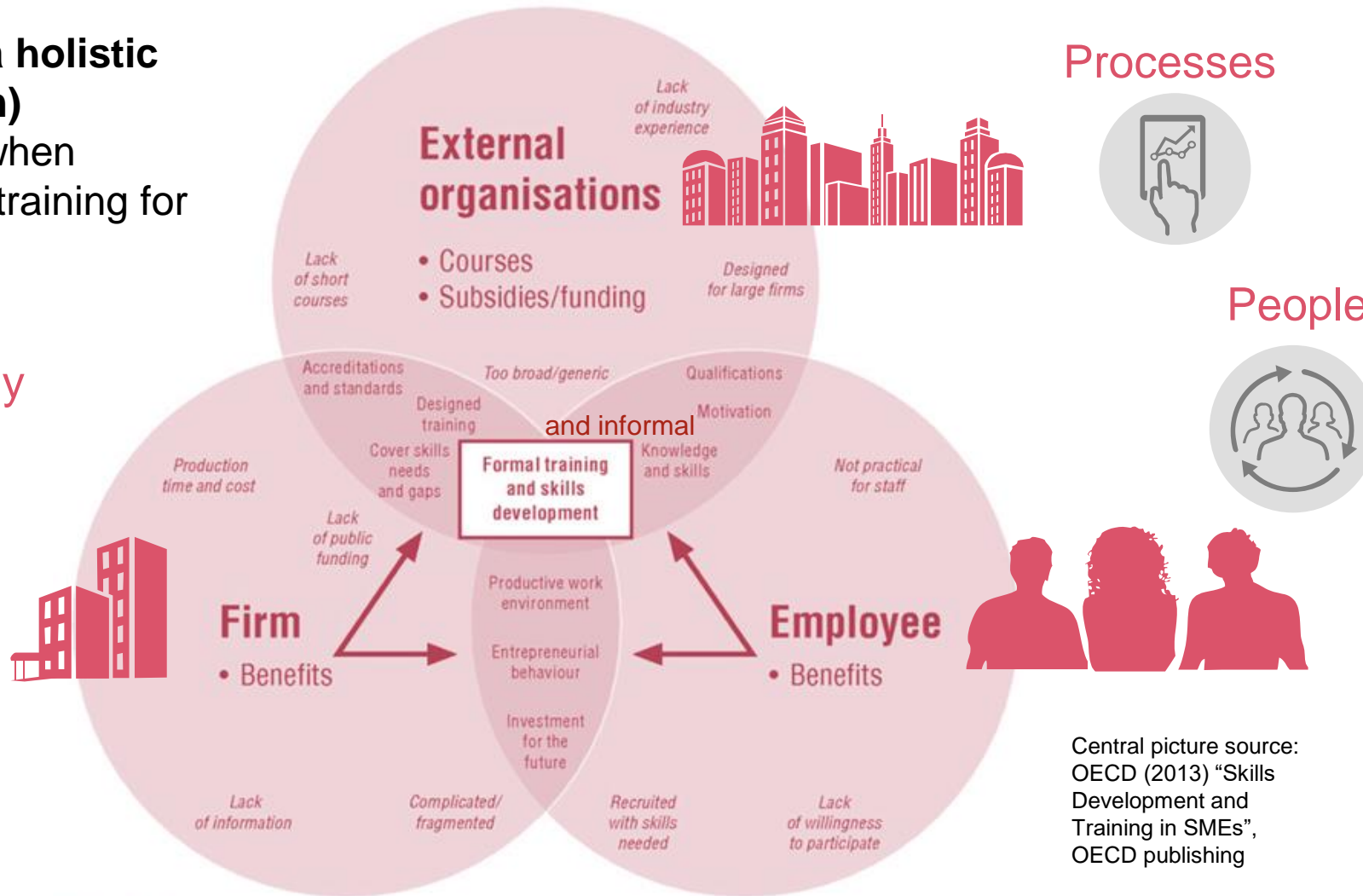
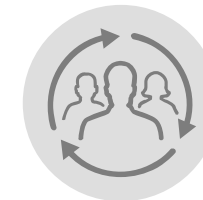

3 Key needs of SMEs to enable effective upskilling/reskilling of workers

The role of clusters in creating learning ecosystems (Part 1)

- Establishing **communities of practice for companies** engaged or considering to get engaged in (online) training, where good practices and experiences can be exchanged by companies directly
- Setting up **collaboration platforms** (including small and large companies, training providers and support structures) with regard to anticipating skill needs for a certain sector, including dissemination of knowledge and sharing of good practices for identifying skill needs
- Developing **libraries of courses** pertinent to SMEs to train their employees in local language using (online) training tailored to the local context

3 Key needs of SMEs to enable effective upskilling/reskilling of workers

The role of clusters in creating learning ecosystems (Part 2)

- **Facilitating partnerships** between training developers & providers and companies (including learners themselves) in order to develop relevant training
- **Providing spaces for experimentation and innovation** at a collaborative level, i.e. an online collaborative space for online training developers and practitioners, in which they can experiment and share good practices
- **Initiating and supporting multi-stakeholder knowledge alliances and thematic networks** aiming to share experience and expertise on online training, and creating a framework for structural collaboration on the joint development, delivery and use of online training for the EU labour market

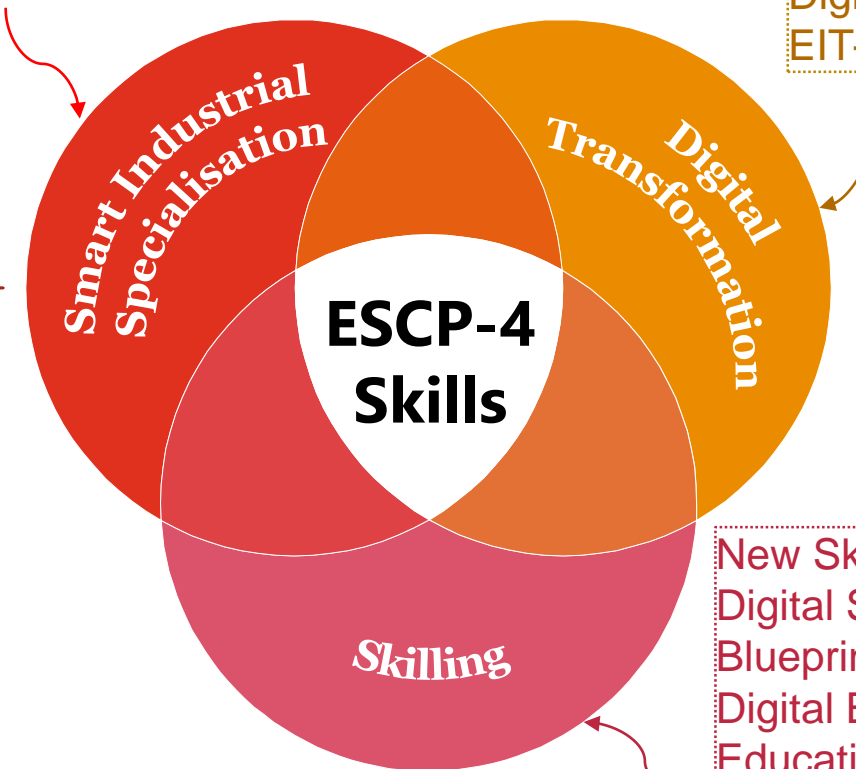
